ORDER

Mr.K.Mahesh, learned Special Government Pleader appearing on behalf of the 3rd respondent submitted that the complaint given by the petitioner has been taken on file and the petitioner has been called for enquiry on 23.12.2020 at 11.00 a.m. The learned counsel submitted that the 3rd respondent will conduct the enquiry and take necessary action in accordance with law.

4. Taking into consideration the facts and circumstances of the case and also of the fact that the 3rd respondent has already called the petitioner for enquiry, there shall be a direction to the 3rd respondent to enquire the complaint given by the petitioner and take action strictly in accordance with law within a period of four weeks from the date of receipt of a copy of this order.

5. This Writ Petition is disposed of with the above directions. No costs.
