This petition has been filed to extend the time to surrender before the Metropolitan Magistrate Court No.XVII, Saidapet, granted in Crl.Op.No.16369 of 2020, dated 15.10.2020.

2.The learned counsel for the petitioner would submit that earlier, the petitioner has been granted bail by this Court in Crl.Op.No.16369 of 2020, on 15.10.2020 with condition to surrender and execute the sureties before the concerned Magistrate within 15 days. He would further submit that the petitioner was unable to surrender and execute the sureties within 15 days, and thereby, the earlier order had got lapsed and hence, he prays to extend the time to execute the sureties.

3.Heard both sides. The order dated 15.10.2020 in Crl.Op.No.16369 of 2020 has lapsed by efflux of time.
