ORDER

3.Taking into consideration the facts and circumstances of the case and also of the fact that the petitioner has already been called for an enquiry by the Settlement Tahsildar, Alandur, there shall be a direction the Settlement Tahsildar, Alandur to conduct the enquiry and pass final orders strictly in

accordance with law, within a period of six weeks from the date of receipt of a copy of this order.

4.This Writ Petition is disposed of with the above directions. No costs.

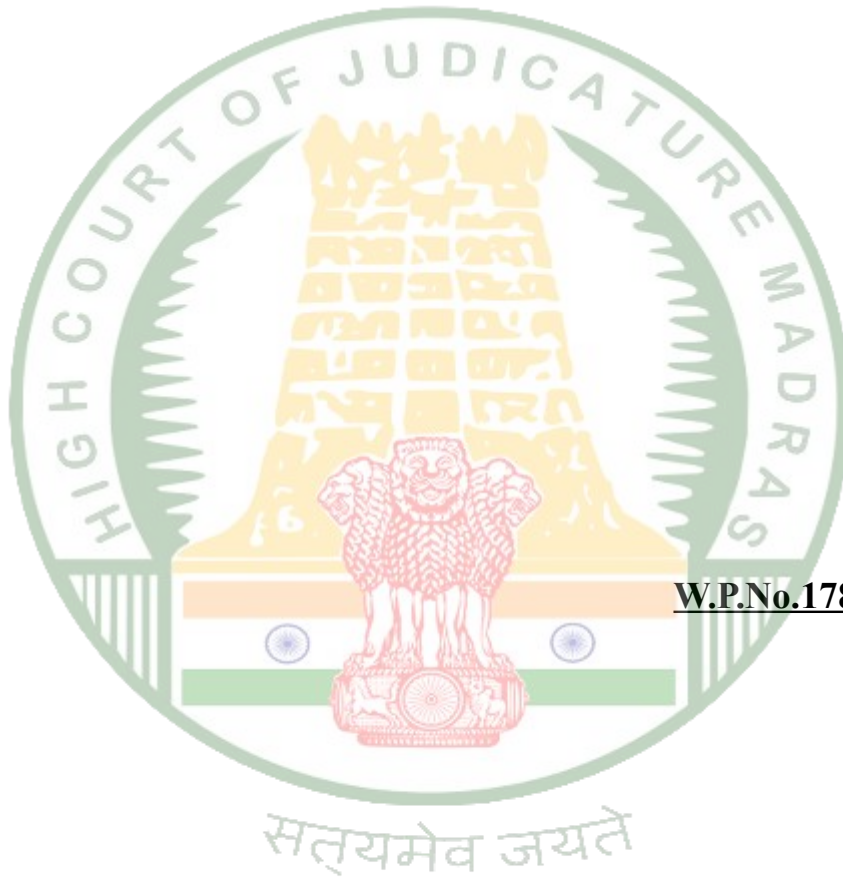
