2. Mr. E.Balamurugan, learned Special Govt. Pleader appearing on behalf of the respondents submitted that the 4th

respondent has already fixed a date for conducting the survey on 17.12.2020 at 3 p.m. The learned counsel further submitted that the survey will be conducted and a report will be submitted before the 2nd respondent .

Taking into consideration the facts and circumstances of the case and also of the fact that the 4th respondent has already called the parties for enquiry and for conducting survey, there shall be a direction to the 4th respondent to complete the entire process strictly in accordance with law and submit a report before the 2nd respondent within a period of six weeks from the date of receipt of a copy of this order.

4. This Writ Petition is disposed of with the above directions. No costs.
