dispute and also the ceremony is scheduled to be held on 03.12.2020, we are inclined to grant 3 days leave to the convict from 03.12.2020 without escort. The convict shall be released from the prison on 03.12.2020 at 10a.m. and he shall return back to the prison on 05.12.2020 at 5p.m.

3. The Crl.M.P. is disposed of accordingly.
