O R D E R

The petitioners have filed the above Writ Petition to issue a Writ of Mandamus forbearing the respondents to consider and dispose of the petitioner's representation dated 16.09.2020 seeking not to disturb the petitioners' peaceful possession and not to dispossess from the property and to grant patta in their favour in S.No.69/2A, 2A6, 2A7 and 2A8 measuring to an extent of 4.80 Acres situated at Palavanthimmanapalli, Chennapalli (P.O.), Hosur Taluk, Krishnagiri District.

2. When the Writ Petition is taken up for hearing, Mr. K. With these observations, the Writ Petition is disposed of. No costs. Consequently, the connected Miscellaneous Petition is closed.

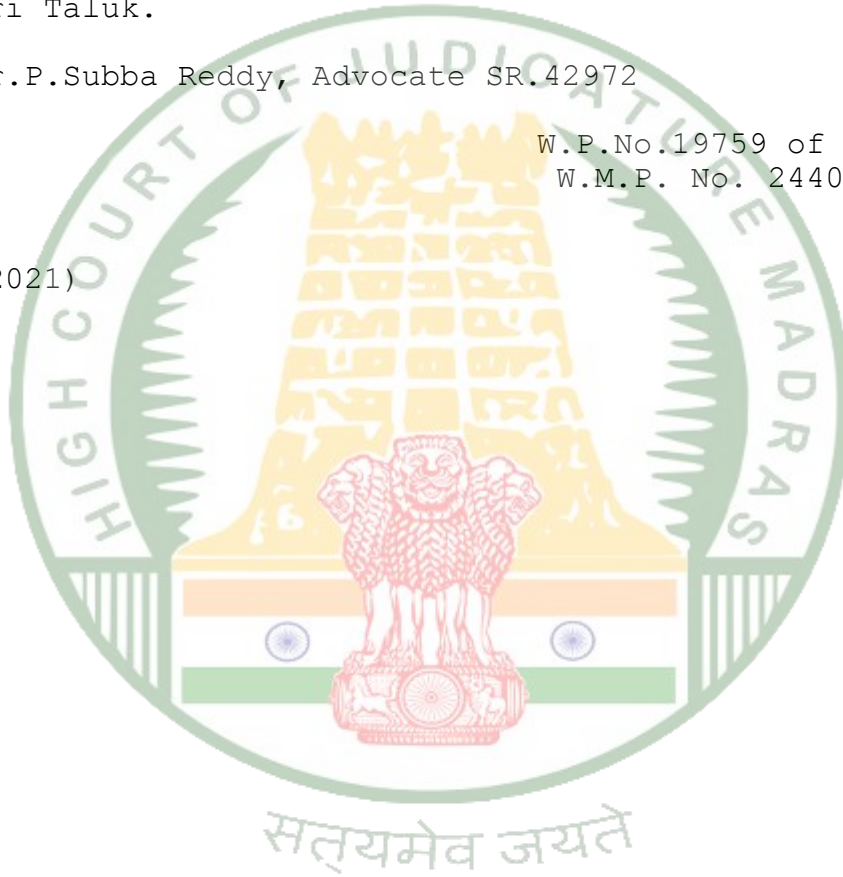
