Considering the said submission, the condition imposed by this Court in CrI.O.P.No.17138 of 2020 dated 03.11.2020 is modified to the effect that the petitioner shall report before the respondent police everyday at 5.30 p.m and also appear before the learned V Metropolitan Magistrate, Egmore, Chennai on the first working day of January 2021 and February 2021 and on the dates fixed by the concerned Magistrate Court.

5. With the above directions, this Criminal Miscellaneous Petition is ordered.
