O R D E R

(The case has been heard through video conference)

The petitioner, who apprehends arrest at the hands of the respondent police for the offence punishable under Sections 4(1)(aaa) r/w 4(1-A) of TNP Act 2000 and 4 & 5 of TNRS Rules, in Crime No.723 of 2020 on the file of the respondent police, seeks anticipatory bail.

2. The case of the prosecution is that the petitioner was found in illegal possession of 110 liters of Illicit Arrack, without any valid permission. Hence, the complaint.

3. The learned counsel for the petitioner submitted that the petitioner is an innocent and she has not committed any offence as alleged by the prosecution. Hence, he prays for grant of anticipatory bail to the petitioner.

4. The learned Additional Public Prosecutor would submit that the petitioner was found in illegal transportation of 110 liters of illicit arrack. He would further submit that there are three previous cases against the petitioner. Hence, he would vehemently oppose for the grant of anticipatory bail to the petitioner.

5. Taking into consideration the nature of offence and the fact that there are three previous cases against the petitioner, this Court is not inclined to grant anticipatory bail to the petitioner. Accordingly, this Criminal Original Petition is dismissed.
