4.Recording the submission made by the learned Government Advocate for the respondents to the effect that the 2<sup>nd</sup> respondent would conduct enquiry and pass orders on merits and in accordance with law, within a period of four weeks from 06.01.2021, the Writ Petition is disposed of.
