**ORDER**

It is represented by the Additional Public Prosecutor that following the complaint lodged by T.Jayakumar, investigation is pending. Further, it is represented that due to the involvement of the petitioner, FIR has been registered in Crime No.528 of 2020 dated 18.06.2020.
