O R D E R

This petition has been filed to call for the records in Na.Ka.2286/2019/B2 dated 16.08.2019 and quash the same as illegal and direct the 2<sup>nd</sup> respondent to give protection to the petitioners to perform the annual festival for Sri Unnja Marathu Karuparayan Kovil, Senjillapalayam, Shanthi Palayam Village, Nambiyur Taluk, Erode District on 03.09.2019.
