Prayer:Appeal filed under Section 54 of the Land
Acquisition Act against the Judgment and Decree of the
Subordinate Court, Dharmapuri in LAOP No. 9 of 2013 dated
22/07/2016.

DECREE:This Appeal coming on for hearing on this day, and
having listed Under the Caption for Being Mentioned on
24/09/2020 and upon perusing the grounds of appeal the
Judgment and Decree of the Trial Court and the material
papers in the suit and upon hearing the arguments of
Mr.J.Bala Gopal, Special Government Pleader for the
Appellant and of Mr.S.C.Vishwanth, Advocate for the first
Respondent and of Mr.Jayesh B.Dolia for M/s.Aiyar & Dolia
for the second Respondent and this Court while allowing the
appeals filed by the Appellant/Land Acquisition Officer by
observing that the first respondent/Claimant had received
some amount, vide order dated 12/10/2017 made in CMP
No.14683/2017 in A.S.No.427/2017 doth order and decree as
follows;

i)That the compensation is be and hereby fixed at Rs.6 Lakhs per acre, which shall be at Rs.13.77 per sq ft for the acquired land;

ii)That the First Respondent/Claimant is be and hereby entitled to the Statutory benefits as per the land Acquisition Act including interest and Solatium of 30%;

iii)That the 1st Respondent/Claimant shall withdraw the amount, if they are entitled for more amount than that was already received by the 1st Respondent/Claimant, by filing appropriate application before the Reference Court after satisfaction of Judgment and Decree of this Appeal;

iv)That the Appellant/Land Acquisition officer is hereby permitted to withdraw the excess amount, if any already deposited before reference Court, after adjusting the amount awarded in this Appeal;

v)That the Special Government Pleader be and hereby is entitled for separate fee in this Appeal;

vi)that there be no costs in this Appeal;
