2. The contesting respondents i.e. R1 and R2 have filed a counter today, wherein they confirm that G.O.Ms.No.73 has been kept in abeyance by G.O.Ms.No.150 dated 19.11.2019, Municipal

Administration and Water Supply (MA.IV) Department. This is recorded.
