This Criminal Original Petition has been filed for a direction to direct the first respondent to grant adequate police protection to the officials of Tamil Nadu Slum Clearance Board to survey and demarcate the petitioner land situated in Plot No.43, Door.No.135, Gandhi Street, Periyar Nagar, Thiruvannamiyur, Chennai-41.
