3.The learned Additional Public Prosecutor appearing for the respondent would submit that after conducting enquiry CSR has been closed as early as on 22.11.2019 and also the closure report was sent to the petitioner by RPAD on the same day.

4.It is seen from the records that after enquiry CSR has been closed on 22.11.2019. Therefore, the Criminal Original Petition is dismissed. However, the 4th respondent is directed to send the closure report to the petitioner within a period of two weeks from the date of receipt of a copy of this order. On receipt of the same, the petitioner is at liberty to file a private complaint before the concerned Court.

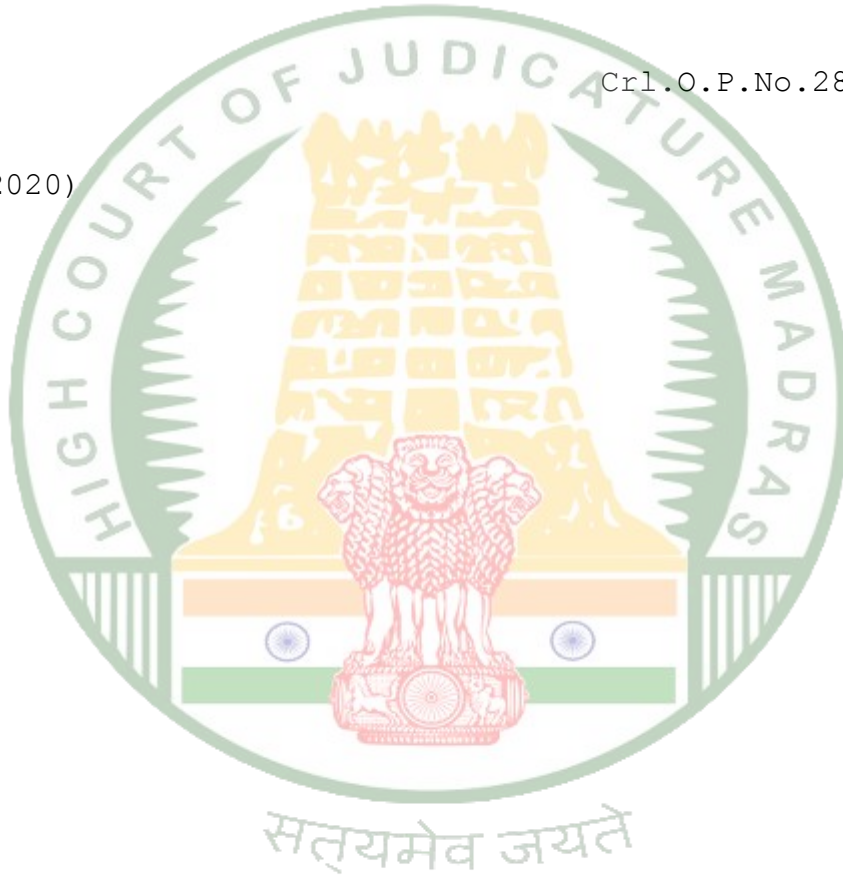
