The petitioner challenges the impugned order of detention in Memo No.05 of 2019 dated 13.10.2019 detaining her husband as "Black Marketeer", as contemplated under Section 3(2)(b) r/w 3 (1) of the Prevention of Black Marketing and Maintenance of Supplies of Essential Commodities Act, 1980.

2. The learned Additional Public Prosecutor reports that the order of detention passed against the detenu has been revoked by the Government by its order in G.O.Rt.No.244 Cooperation, Food and Consumer Protection (E2) Department, dated 04.11.2019 and he has also produced a copy of the Government Order. Recording the same, this Habeas Corpus Petition stands closed.
