This petition has been filed seeking transfer of investigation in Crime No.95 of 2016.

2.The learned Additional Public Prosecutor for the respondents, on instructions, submitted that after completion

of investigation, the respondent police filed charge sheet before the Judicial Magistrate, Vandavasi and the same was taken on file as S.T.C.No.91 of 2016 for the offence under Sections 294(b) and 323 of IPC. He further submitted that the accused namely Venkatesan and Bhuvaneswari had appeared before the Judicial Magistrate, Coimbatore and pleaded guilty and the fine amount was also paid on 16.07.2016.
