(i) directing the first respondent to dispose of the appeal petitions B2/7397/2007 dated 10.6.2007 filed by the petitioner to set aside the assessment order passed by the second respondent fixing the ULT at Rs.28,319/- which was reserved on 07.10.2013 in respect of Paravai Village in survey Nos.200/1, 200/2, 200/3, 200/4, 200/5, 200/6, 200/7, 200/8, 200/9, 200/10 & 200/11 (new survey Nos.90/1, 90/2, 90/3, 90/4, 90/5, 90/6, 90/7, 90/8, 90/9, 90/10 & 90/11) measuring an extent of 177 ground and 12531 sq.feet; and

(ii) directing the first respondent to dispose of the revisions petitions B2/7397/2007 dated 25.7.2009 filed by the petitioner to set aside the assessment order passed by the second respondent fixing the ULT at Rs.74,182/- which was reserved on 07.10.2013 in respect of Bit-II Paravai Village in survey Nos.114/5, 114/6, 114/7, 114/8, 114/9, 247/1, 280/1, 280/2, 280/3, 280/5, 281/1, 281/2, 281/3, 281/4, 281/5, 281/6, 281/7, 281/8, 282/13 and 282/8B (New survey Nos.26/5, 26/6, 26/7, 26/8, 26/9, 109/1, 55/1, 55/2, 55/3, 55/5, 56/1, 56/2, 56/3, 56/4, 56/5, 56/6, 56/7, 56/8, 57/13 & 57/8A) measuring an

extent of 426 ground and 27156 sq.feet. in Paravai Bit-I and Bit-II Part Village Madurai North Taluk, respectively.
