COMMON ORDER

The petitioner initiated proceedings under Section 138 Negotiable instruments Act as against the second respondent in C.C.Nos.7983 and 7990 of 2018 on the file of the learned Metropolitan Magistrate, FTC-I, Allikulam,

2. On receipt of summons, the accused person viz., the second respondent did not appear before the trial Court. Therefore, the trial Court has issued a bailable warrant to the second accused and it is pending on the file of the third

respondent.

3. Considering the above facts and circumstances, the third respondent is directed to execute the bailable warrant issued by the learned Metropolitan Magistrate, FTC-I, Allikulam in C.C.No. 7983 and 7990 of 2018 within a period of six weeks from the date of receipt of a copy of this order. The petitioner / de-facto complaint is also directed to co-operate with the third respondent and furnish the correct address to the second respondent to execute the bailable warrant.

4. With the above direction, these Criminal Original Petitions are disposed of.
