2. The learned counsel for the petitioner submitted that one of the accused has not been impleaded in Cr.No. 208 of 2019 and he also represented before the Deputy Commissioner of Police.

3. The learned Additional Public Prosecutor submitted that the entire investigation has been completed and after getting approval of the learned Additional Public Prosecutor, the final report has been laid before the learned XVIII Metropolitan Magistrate, Saidapet, Chennai. It was returned for the reason of pandemic circumstances of Covid-19.

4. Considering the submission made by the learned Additional Public Prosecutor, the transfer of investigation does not arise since already investigation has been completed. Therefore, this Criminal Original Petition is dismissed.
