ORDER

4.Having regard to the submissions made by the learned Special Government Pleader and also taking into consideration the averments stated in the affidavit filed in support of the

petition, I direct the 2nd respondent to consider the petitioner's representation dated 17.08.2016 and pass orders, on merits and in accordance with law, within a period of six weeks from the date of receipt of a copy of this order.

5. With these observations, the Writ Petition is disposed of.

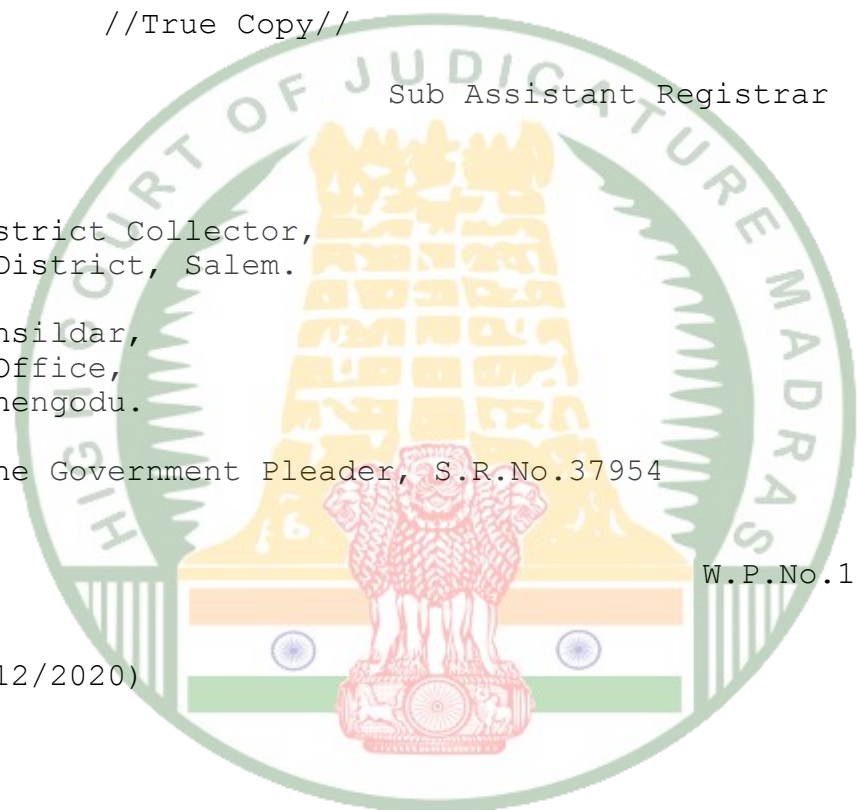
