3.Heard the parties.

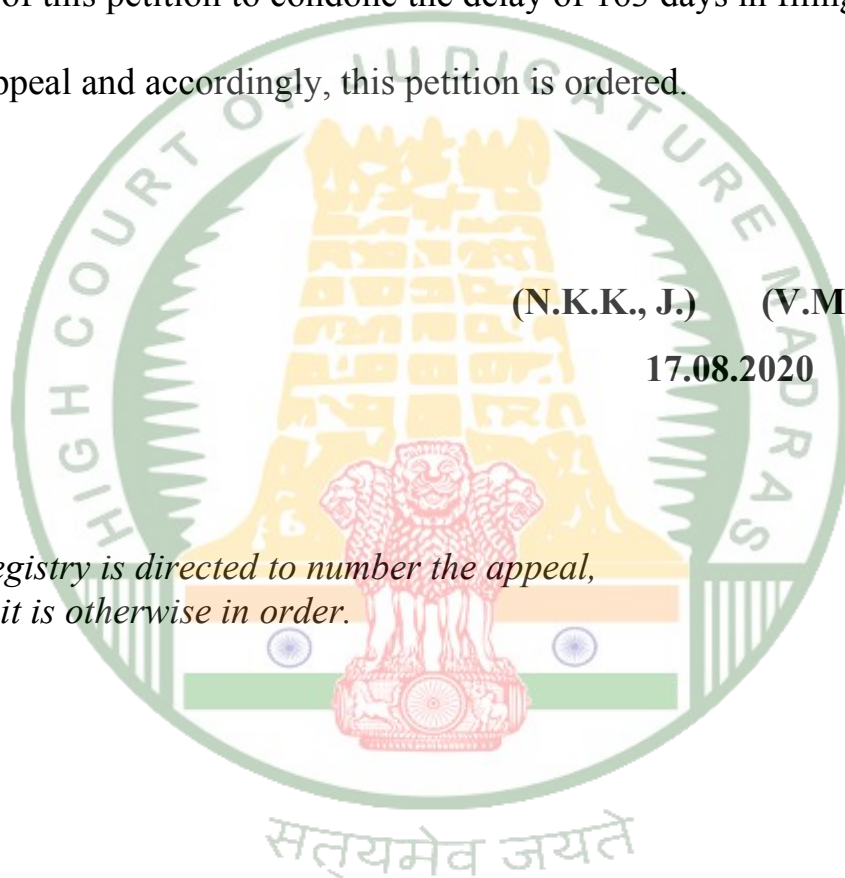

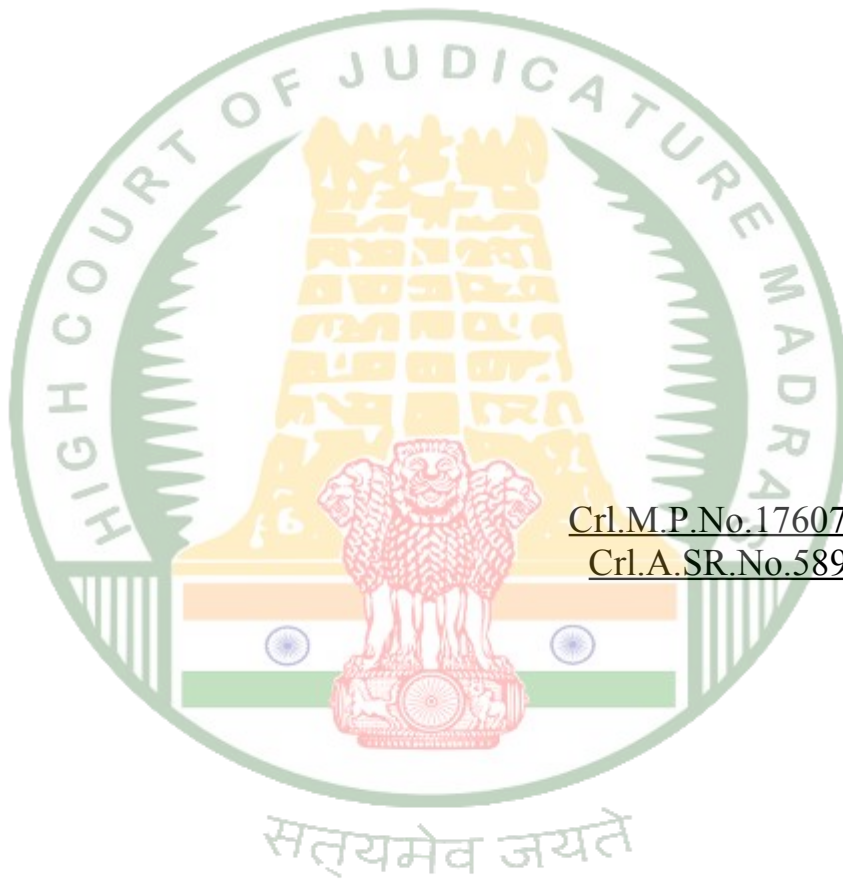
