Velankanni, aged about 22 years, the detenu at liberty forthwith.

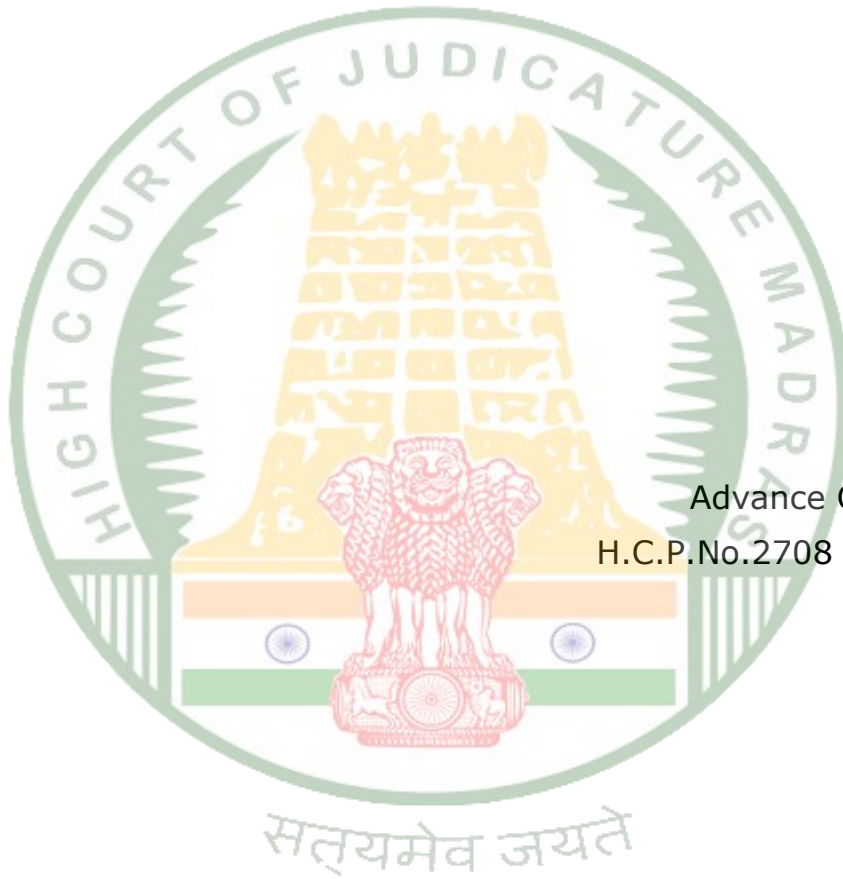
