Petition filed under Article 226 of the Constitution of India to issue a writ of habeas corpus, to call for the records and quash the same leading to the detention of the petitioner's son namely Senthil @ Pukka, male aged 22 years, S/o Kannan, detained under Section 2(f) of the Tamil Nadu Act 14/82 vide detention order, dated 7.11.2019 on the file of the second respondent herein, made in No.759/B.C.D.F.G.I.S.S.S.V./2019, and consequently, direct the 1st respondent to produce the body and person of the said detainee before this Court and thereafter set him liberty from Central Prison, Puzhal, Chennai.

The petitioner challenges the impugned order of detention in No.759/B.C.D.F.G.I.S.S.S.V./2019, dated 07.11.2019 detaining her son as "Goonda", as contemplated under Section 2(f) of the Tamil Nadu Act 14 of 1982.

The learned Additional Public Prosecutor reports that the order of detention passed against the detenu has been revoked by the Government by its order in G.O.Rt.No.65 Home, Prohibition and Excise (XIII) Department, dated 07.01.2020 and he has also produced a copy of the Government Order. Recording the same, this Habeas Corpus Petition stands closed.
