Vide order dated 12.12.2019, while granting bail, this Court imposed condition to deposit a sum of Rs.2,00,000/- within a period of of four weeks to the credit of C.C.No.6 of 2006 on the file of the learned II Additional District Judge for CBI cases, Coimbatore.

2. A memo has been filed today wherein it is stated that pursuant to the above order, an amount of Rs.2,00,000/- has been deposited to the credit of C.C.No.6 of 2006 on the file of II Additional District Judge for CBI Cases, Coimbatore. The above memo dated 08.01.2020 is taken on record.

3. The II Additional District Judge for CBI cases, Coimbatore is directed to deposit the entire amount lying in credit of C.C.No. 6 of 2006 with the Canara Bank, Nerkundram Branch, Chennai, in an interest bearing deposit initially for a period of two years and to keep it renewed periodically till the disposal of the case.

4. With the above direction this criminal miscellaneous petition is closed
