COMMON ORDER

The matter is heard through "Video Conferencing".

2.At request of the learned counsel appearing for the petitioners, this matter is listed today before this Court under the caption "for being mentioned".

3.Learned counsel appearing for the petitioners would submit that in paragraph 8(i) of the earlier order of this Court dated 31.07.2020, it has been mentioned as "the accused 2 and 3 are directed to execute their own bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) each before the **"Superintendent of Prison, Central Prison, Salem"** " instead of **"Superintendent of Prison, Central Prison, Coimbatore"** and seeks for rectification.

4. In view of the above submissions, paragraph 8(i) of the earlier order of this Court dated 31.07.2020 is rectified to read as follows:

“(i) The accused 2 and 3 are directed to execute their own bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) each before the Superintendent of Prison, Central Prison, Coimbatore and the 4th accused is directed to execute his own bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) before the Superintendent of Prison, Central Prison, Coimbatore, in view of the prevailing pandemic situation.”

5. Registry is directed to issue fresh order copy after carrying out the above said corrections. The other contents of the earlier order of this Court dated 31.07.2020 shall remain unaltered.
