The Fourth Respondent has stated in his Counter-Affidavit, that the construction of water tank is taking place only in Survey No. 1058 in poramboke land belonging to the Government in which the Petitioner does not any title and that no construction is taking place in Survey Nos. 1061, 1065 and 1057, which is claimed to be owned by the Petitioner.

2. In the aforesaid circumstances, there is no justification to continue the interim order that has been passed on 30.12.2019. Accordingly, this Miscellaneous Petition is dismissed.
