When it is pointed out by Learned Government Advocate appearing for the Respondent that the Petitioner has got an effective alternative remedy to challenge the impugned order by way of appeal under Section 51 of the Tamil Nadu Value Added Tax Act, 2006, before the Appellate Authority, Learned Counsel for the Petitioner seeks permission of this Court to withdraw this
