2. That there be no costs in this Appeal Suit.

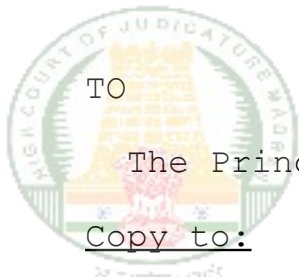
