2. The petitioner apprehending arrest at the hands of the
respondent police for the offences punishable under sections 120(b),
408, 409, 420, 465, 467, 468, 471 and 477(A) read with 109 of
I.P.C., in Crime No.Not Known of 2020 on the file of the respondent
police, seeks anticipatory bail.

3. The learned Government Advcoate states that they are yet to
register a First Information Report and they are not even received
any complaint.

4.The learned Counsel for the petitioner on the other hand

This arrangement is directed so as to give breathing time to the petitioners to move this Court for the relief. This direction shall be strictly adhere by the respondent.

6.Subject to this direction, this Criminal Original Petition stands disposed of.
