PRAYER :-

Heard the learned counsel appearing for the petitioners and the learned Government Advocate(Crl. Side) appearing for the respondent. The intervenor also entered appearance through her counsel.

2. The petitioners apprehending arrest at the hands of the respondent police for the offence punishable under section 498(A) of I.P.C., in Crime No.Not Known of 2020 on the file of the respondent police, are granted anticipatory bail.



3. The learned Government Advocate (Crl.side) states that FIR has not been registered so far and that the matter has been referred to the Social Welfare Officer for mediation.
