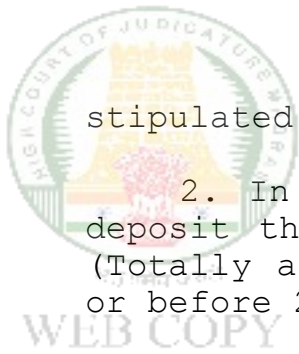
Prayer in CMA(MD)No.SR11032 of 2018:
