PRAYER : Criminal Original Petition is filed under Section 482 of Cr.P.C. to admit the quash petition on file to call for the records in Crime No. 02 of 2019 on the file of the All Women Police Station, Palayamkottai, Tirunelveli City and to quash the same on the ground of compromise.

ORDER

The Criminal Original Petition has been filed to quash the First Information Report in Crime No. 02 of 2019 on the file of the All Women Police Station, Palayamkottai, Tirunelveli City, for the offences punishable under Sections 417,376,312,506(i) of IPC r/w.3 (1) (w) (i), 3(2) (v), 3(2) (va) of SC/ST (POA) Amendment Act, 2015.

2. The case of the prosecution is that the third respondent is a practising advocate for a past eight years and she was elected as



a Executive Member in the Women Bar Association, Tirunelveli. The petitioner was elected as a Secretary in Tirunelveli District Bar Association in the year 2017. When the petitioner met the third respondent he promised to marry her. While being so, on 02.08.2017 at about 05.00p.m the petitioner picked the third respondent in this car and went to petitioner's house for discussion with his mother about their marriage. Subsequently at about 05.30 p.m the petitioner gave a cool drink to the third respondent out of that she become unconscious during that time the petitioner raped her. After that the petitioner frequently met the third respondent and had sexual intercourse with her because of that she became pregnant and she under went abortion two time at Kamala Mariammal Hospital, Kovilpatti and Padmavathy Hospital, Kovilpatti. It is further submitted that whenever the third respondent met the petitioner and requested him to marry her, the petitioner prolonged the issue and further submitted that after the death of the petitioner's mother, 17 days later the petitioner married some other lady and the when the third respondent questioned the same, the petitioner threatened her with dire consequences. Hence the complaint.

3. The learned counsel appearing for the petitioner as well as the learned counsel appearing for the third respondent submitted that now, the petitioner and the third respondent/defacto complainant have settled the dispute between themselves amicably and the third respondent/defacto complainant is not willing to proceed further with the criminal case.

4. Today, when the matter was taken up for hearing, both the petitioner and the third respondent/defacto complainant are present in Court and they are identified by their respective counsel and also identified by the respondent police. The third respondent and the petitioner stated that they are practising advocates belonging to the same bar and that it has been stated by the third respondent that the petitioner and the third respondent were best friends and that out of emotions she has given a false complaint stating that the petitioner had given her cool drinks laced with sedative and also raped her. Now she had realized the situation and accepted her mistake and she had intended to withdraw the complaint against the petitioner. She has also filed an affidavit stating that she had given a false complaint out of emotions. The relevant portion of the affidavit reads as follows:

"2. I submit that based on my complaint the second respondent registered the case in Crime No.2 of 2019 for the offences under Sections 417,376,312,506(i) of IPC r/w.3(1)(w)(i),3(2)(v), 3(2)(va) of SC/ST (POA) Amendment Act, 2015 and I further submitted that I am the best friend of the petitioner herein and out of emotions, I have given a false complaint stating that the petitioner gave a cool drinks and raped me, but I now realized the situation. I further submitted that



myself and the petitioner are practising in the same District court and also I like to lead my future life peacefully so I don't want to proceed the FIR. Hence I have filed the joint compromise memo for quashing the FIR in Crime No. 2 of 2019 on the file of the second respondent".

5. The case has been registered for offences under Sections 417,376,312,506(i) of IPC r/w.3(1)(w)(i),3(2)(v), 3(2)(va) of SC/ST (POA) Amendment Act, 2015. It is settled law that the High Court has inherent power under Section 482 of the Code of Criminal Procedure to quash the criminal proceedings even for the offences which are not compoundable under Section 320 of the Code of Criminal Procedure, where the parties have settled their dispute between themselves. However, while quashing the criminal proceedings, based on the settlement arrived at between the parties, the High Court should act with caution and the power should be exercised sparingly only in order to secure the ends of justice and also to prevent abuse of process of any Court.

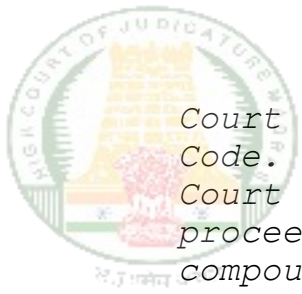
6. In **Gian Singh vs. State of Punjab [2012 (10) SCC 303]**, the Supreme Court has held as follows:

"61. The position that emerges from the above discussion can be summarised thus: the power of the High Court in quashing a criminal proceeding or FIR or complaint in exercise of its inherent jurisdiction is distinct and different from the power given to a criminal court for compounding the offences under Section 320 of the Code. Inherent power is of wide plenitude with no statutory limitation but it has to be exercised in accord with the guideline engrafted in such power viz.: (i) to secure the ends of justice, or (ii) to prevent abuse of the process of any court. In what cases power to quash the criminal proceeding or complaint or FIR may be exercised where the offender and the victim have settled their dispute would depend on the facts and circumstances of each case and no category can be prescribed. However, before exercise of such power, the High Court must have due regard to the nature and gravity of the crime. Heinous and serious offences of mental depravity or offences like murder, rape, dacoity, etc. cannot be fittingly quashed even though the victim or victim's family and the offender have settled the dispute. Such offences are not private in nature and have a serious impact on society."

7. In **Narinder Singh v. State of Punjab [2014(6) SCC 466]**, after considering the **Gian Singh's** case referred to above, the Hon'ble Supreme Court has held as follows:

29.1. Power conferred under Section 482 of the Code

is to be distinguished from the power which lies in the



Court to compound the offences under Section 320 of the Code. No doubt, under Section 482 of the Code, the High Court has inherent power to quash the criminal proceedings even in those cases which are not compoundable, where the parties have settled the matter between themselves. However, this power is to be exercised sparingly and with caution.

29.2. When the parties have reached the settlement and on that basis petition for quashing the criminal proceedings is filed, the guiding factor in such cases would be to secure:

- (i) ends of justice, or
- (ii) to prevent abuse of the process of any court.

While exercising the power the High Court is to form an opinion on either of the aforesaid two objectives.

29.3. Such a power is not to be exercised in those prosecutions which involve heinous and serious offences of mental depravity or offences like murder, rape, dacoity, etc. Such offences are not private in nature and have a serious impact on society. Similarly, for the offences alleged to have been committed under special statute like the Prevention of Corruption Act or the offences committed by public servants while working in that capacity are not to be quashed merely on the basis of compromise between the victim and the offender.

29.4. On the other hand, those criminal cases having overwhelmingly and predominantly civil character, particularly those arising out of commercial transactions or arising out of matrimonial relationship or family disputes should be quashed when the parties have resolved their entire disputes among themselves.

29.5. While exercising its powers, the High Court is to examine as to whether the possibility of conviction is remote and bleak and continuation of criminal cases would put the accused to great oppression and prejudice and extreme injustice would be caused to him by not quashing the criminal cases."

8. In **Parbatbhai Aahir v. State of Gujarat [AIR 2017 SC 4843]**, the Supreme Court held thus"

"(1) Section 482 CrPC preserves the inherent powers of the High Court to prevent an abuse of the process of any court or to secure the ends of justice. The provision does not confer new powers. It only recognises and preserves powers which inherent in the High Court.



(2) The invocation of the jurisdiction of the High Court to quash a first information report or a criminal proceeding on the ground that a settlement has been arrived at between the offender and the victim is not the same as the invocation of jurisdiction for the purpose of compounding an offence. While compounding an offence, the power of the court is governed by the provisions of Section 320 CrPC. The power to quash under Section 482 is attracted even if the offence is non-compoundable.

(3) In forming an opinion whether a criminal proceeding or complaint should be quashed in exercise of its jurisdiction under Section 482, the High Court must evaluate whether the ends of justice would justify the exercise of the inherent power.

(4) While the inherent power of the High Court has a wide ambit and plenitude it has to be exercised (i) to secure the ends of justice, or (ii) to prevent an abuse of the process of any court.

(5) the decision as to whether a complaint or first information report should be quashed on the ground that the offender and victim have settled the dispute, revolves ultimately on the facts and circumstances of each case and no exhaustive elaboration of principles can be formulate.

(6) In the exercise of the power under Section 482 and while dealing with a plea that the dispute has been settled, the High Court must have due regard to the nature and gravity of the offence. Heinous and serious offences involving mental depravity or offences such as murder, rape and dacoity cannot appropriately be quashed though the victim or the family of the victim have settled the dispute. Such offences are, truly speaking, not private in nature but have a serious impact upon society. The decision to continue with the trial in such cases is founded on the overriding element of public interest in punishing persons for serious offences.

(7) As distinguished from serious offences, there may be criminal cases which have an overwhelming or predominant element of a civil dispute. They stand on a distinct footing insofar as the exercise of the inherent power to quash is concerned.

(8) Criminal cases involving offences which arise from commercial, financial, mercantile, partnership or similar transactions with an essentially civil flavour may in appropriate situations fall for quashing where parties have settled the dispute.



(9) In such a case, the High Court may quash the criminal proceeding if in view of the compromise between the disputants, the possibility of a conviction is remote and the continuation of a criminal proceeding would cause oppression and prejudice; and

(10) There is yet an exception to the principle set out in Propositions (8) and (9) above. Economic offences involving the financial and economic well-being of the State have implications which lie beyond the domain of a mere dispute between private disputants. The High Court would be justified in declining to quash where the offender is involved in an activity akin to a financial or economic fraud or misdemeanour. The consequences of the act complained of upon the financial or economic system will weigh in the balance."

9. Recently, in **State of Madhya Pradesh v. Laxmi Narayan [AIR 2019 SC 1296]**, the Hon'ble Supreme Court, considering all the above judgments, has held as follows:

"i) that the power conferred under Section 482 of the Code to quash the criminal proceedings for the non-compoundable offences under Section 320 of the Code can be exercised having overwhelmingly and predominantly the civil character, particularly those arising out of commercial transactions or arising out of matrimonial relationship or family disputes and when the parties have resolved the entire dispute amongst themselves;

ii) such power is not to be exercised in those prosecutions which involved heinous and serious offences of mental depravity or offences like murder, rape, dacoity, etc. Such offences are not private in nature and have a serious impact on society;

iii) similarly, such power is not to be exercised for the offences under the special statutes like Prevention of Corruption Act or the offences committed by public servants while working in that capacity are not to be quashed merely on the basis of compromise between the victim and the offender;

iv) offences under Section 307 IPC and the Arms Act etc. would fall in the category of heinous and serious offences and therefore are to be treated as crime against the society and not against the individual alone, and therefore, the criminal proceedings for the offence under Section 307 IPC and/or the Arms Act etc. which have a serious impact on the society cannot be quashed in exercise of powers under Section 482 of the Code, on the ground that the parties have resolved their entire dispute



amongst themselves. However, the High Court would not rest its decision merely because there is a mention of Section 307 IPC in the FIR or the charge is framed under this provision. It would be open to the High Court to examine as to whether incorporation of Section 307 IPC is there for the sake of it or the prosecution has collected sufficient evidence, which if proved, would lead to framing the charge under Section 307 IPC. For this purpose, it would be open to the High Court to go by the nature of injury sustained, whether such injury is inflicted on the vital/delegate parts of the body, nature of weapons used etc. However, such an exercise by the High Court would be permissible only after the evidence is collected after investigation and the charge sheet is filed/charge is framed and/or during the trial. Such exercise is not permissible when the matter is still under investigation. Therefore, the ultimate conclusion in paragraphs 29.6 and 29.7 of the decision of this Court in the case of Narinder Singh (supra) should be read harmoniously and to be read as a whole and in the circumstances stated hereinabove;

v) while exercising the power under Section 482 of the Code to quash the criminal proceedings in respect of non-compoundable offences, which are private in nature and do not have a serious impart on society, on the ground that there is a settlement/compromise between the victim and the offender, the High Court is required to consider the antecedents of the accused; the conduct of the accused, namely, whether the accused was absconding and why he was absconding, how he had managed with the complainant to enter into a compromise etc."

10. Keeping the above principles in mind, let us now consider the instant case as to whether it is a fit case to quash the criminal proceedings based on the settlement arrived at between the parties.

11. In the case at hand, though the petitioner is charged with for the offences punishable under Sections 417,376,312,506(i) of IPC r/w.3(1)(w)(i),3(2)(v), 3(2)(va) of SC/ST (POA) Amendment Act, 2015, now, the petitioner and the third respondent/defacto complainant have amicably settled their dispute between themselves . The third respondent/defacto complainant has also filed a sworn affidavit stating that she has given a false complaint out of emotion. The third respondent is a practising lawyer capable of understanding the consequences. The case is also at the stage of investigation. The third respondent/defacto complainant is also not interested in prosecuting the criminal proceedings. In view of the



compromise between the parties, the possibility of conviction is also remote and bleak. In the above circumstances, continuity of the criminal proceedings would only cause oppression and prejudice to the parties, hence, in order to secure the ends of justice, this Court is inclined to quash the criminal proceedings.

12. The learned counsel for the third respondent would submit that the third respondent had expressed her remorse for giving a false complaint she had undertaken to deposit Rs.10,000/- before the Bethel Home, Tirunelveli.

13. Accordingly, this Criminal Original Petition is allowed and the criminal proceedings initiated against the petitioner in Crime No. 02 of 2019 on the file of the All Women Police Station, Palayamkottai, Tirunelveli City, is quashed and the terms of joint compromise memo and affidavit filed by the third respondent shall form part and parcel of this order.

14. Post the matter on 22.01.2020 under the caption " for reporting compliance"
