PRAYER: Petition filed under Article 226 of the Constitution of India to issue a Writ of Certiorarified Mandamus calling for the records from the sixth respondent the Executive Engineer relating to the impugned letter passed in E.Va.Aa 3/311M/K/250/2009 dated 30.06.2010 and the subsequent impugned letter No.4/237 R/Ko./247/2010 dated 07.07.2010 and quash the same and direct the respondents 5 and 6 to invite and involve by conducting necessary meeting the petitioner project committee through its Chairman and members of the Committee periodically with reference to all the matters, acts and activities specified under Section 24 and other provisions of the Tamil Nadu Farmers Management Irrigation System Act in formulation and in executing various schemes, compulsorily failing which direct disciplinary action to be taken against the respondents 6 and 5 within a time to be specified by this Court.
