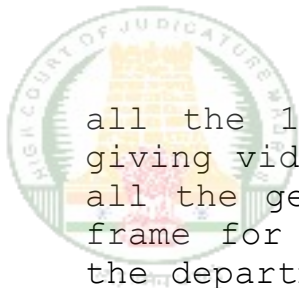

all the 139 shops as 1 to 139 and conduct open auction after giving wide publicity in local newspapers by giving opportunity to all the general public also it is highly necessary to fix a time frame for conducting the auction by monitoring higher officer of the department.

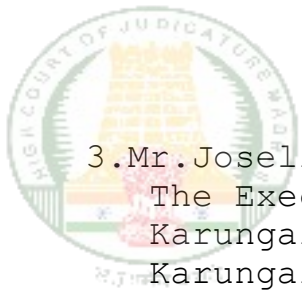
