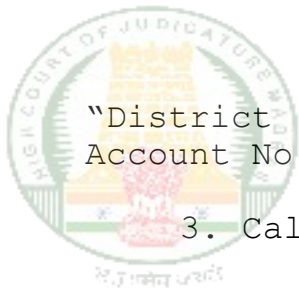
PRAYER IN CMA(MD)No.SR.39243 of 2018:
