PRAYER :-

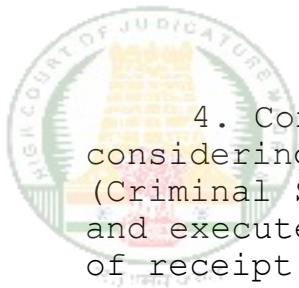
to extend the time limit granted Crl.OP(MD)No.8553 of 2018 dated 18.06.2018.
