PRAYER :-

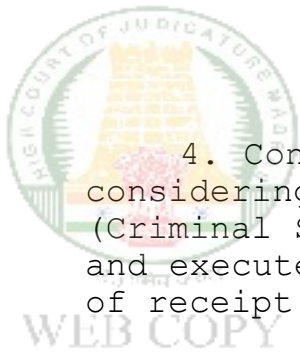
To extend the time for compliance of the orders passed by this Hon'ble Court on 13/12/2019 in Crl.O.P.(MD) NO.18746 of 2019.
