PRAYER :-

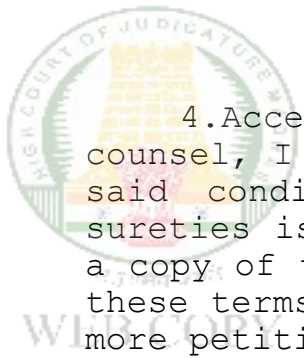
To grant extension of time granted in the order made in
