PRAYER :-

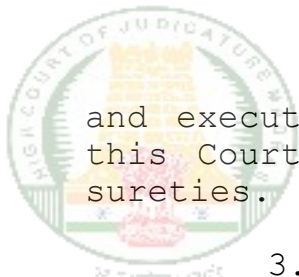
