PRAYER :-

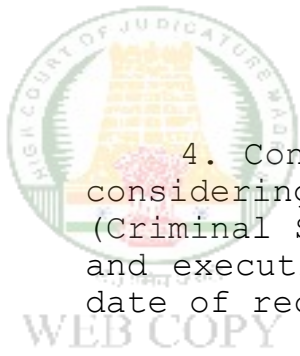
To extend the time fixed by this Honourable Court in Crl.O.P.
