When the contempt petition is taken up for hearing, Mr.V.R.Shanmuganathan, learned Special Government Pleader appearing for the respondent, submitted that the respondent has complied with the orders of this Court made in W.P.(MD) No.18506 of 2019, dated 27.09.2019, by issuing a notice to the contempt petitioner and granting planning permission to the writ petitioner on 27.01.2020

2. It is also pertinent to note that the contempt petitioner has submitted his objections before the Authority concerned, which according to the learned Special Government Pleader appearing for the respondent, were considered and thereafter, planning permission was granted to the writ petitioner.
