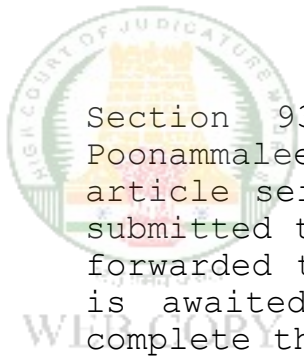
Prayer in CRL OP(MD). No.1070 of 2019 :

This petition has been filed to extend the time for completion of investigation RC.01/2019/NIA/DLI on the file of the Deputy Superintendent of Police, NIA Camp at Ramanathapuram by another three months to unravel entire true facts regarding crime and filing final report.

2. The learned Additional Public Prosecutor would submit that some important evidences relating to the crime is available in the

Section 93 of Cr.P.C were obtained from NIA Special Court, Poonammalee Chennai and searches were conducted on 20.05.2019. The article seized during the search including the digital devices were submitted to NIA Special Court, Poonnamallee, Chennai and have been forwarded to C-DAC, Trivandrum for forensic analysis and the report is awaited. Hence he seeks further time of three months to complete the trial and file the final report.

3. The respondent has no objection in granting further time to the respondent police to file the final report.

4. In view of the same, the time frame in Crl.O.P(MD) No. 1070 of 2019 dated 13.09.2019 is further extended by three months from the date of receipt of a copy of this order.
