COMMON PRAYER: These Petitions are filed under Section 11 of the Contempt of Courts Act, to punish the respondents for wilful deliberate disobedience of the order passed by this Court in W.P. (MD)Nos.83 and 84 of 2019, dated 23.01.2019, respectively.

Prayer in WP(MD)No. 83/ 2019 :

Writ Petition filed under Article 226 of the Constitution of India, praying for issuance of a writ of Mandamus, directing the Respondents to sanction Pay arrears with effect from 01.11.2012 and to sanction Pension arrears with effect from 31.05.2013 being the date of retirement and to pay the difference amount of retirement benefits based on the revised scale of pay along with 18% interest as agreed by the 2nd respondent in his order dated 25.07.2016.

Prayer in WP(MD)No. 84/ 2019 :

Writ Petition filed under Article 226 of the Constitution of India, praying for issuance of a writ of Mandamus, directing the Respondents to sanction Pay arrears with effect from 01.08.2010 and to sanction Pension arrears with effect from 30.06.2011 being the date of retirement and to pay the difference amount of retirement



benefits based on the revised scale of pay along with 18% interest as agreed by the 2nd respondent in his order dated 22.07.2016.
