PRAYER :-

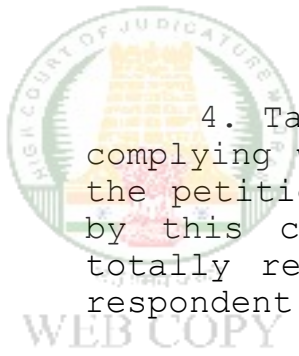
To relax the condition imposed in Crl.O.P.(MD).No.19598/2019 dated 30.12.2019 on the file of this Hon'ble High Court.
