Petition filed under Article 226 of the Constitution of India to issue a Writ of Certiorarified Mandamus, to call for the records relating to the impugned auction notification of the respondent in Na.No.Ko.7/2019/E.Po.1, dated 13.02.2019 and quash the same insofar as the tanks namely Nallur Melakulam and Nallur Keelakumal situated at Nallur Village, Kurumbur Taluk, Tuticorin District and consequently forbear the respondent from interfering with the Fishery right of the petitioner.
