PRAYER :-

To Extend time for 2 weeks period for producing sureties before the Judicial Magistrate No.II, Usilampatti in Crime No.391/2019 in Crl.O.P. No.19630/2019 on 03/01/2020 and thus render justice.

ORDER : The Court Made the following order :-
