PRAYER :-

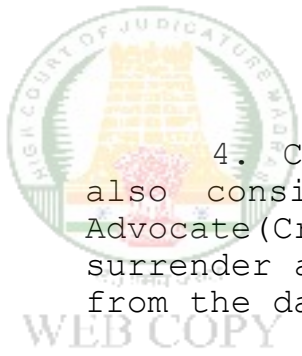
To extend the time stipulated in the Crl.Op(MD)No.19248 of 2019, dated 20.12.2019.
