To extend the time to execute the sureties order made in Crl.O.P.(MD) No.18514 of 2019 dated 10/12/2019 and thus render justice.

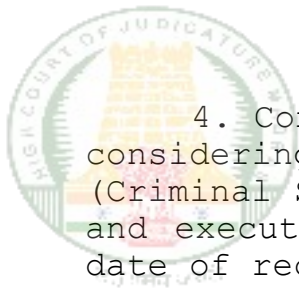
ORDER : The Court Made the following order :-
