PRAYER :-

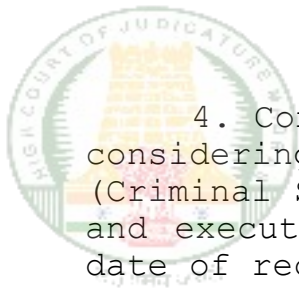
